**ORDER**

As per the U.O. read as 1<sup>st</sup> above, Provisional Affiliation was granted to the new college viz. Sahrdaya Institute of Management Studies, Kallettumkara, Kodakara, Thrissur under Irinjalakuda Diocesan Educational Trust for conducting MBA programme with an intake of 60 seats during the academic year 2015-16.

2. As per the U.O. read as 2<sup>nd</sup> above, the MBA programme was suspended during the academic year 2015-16 with permission to restart the programme during the academic year 2016-17. The Continuation of Provisional to MBA programme with an intake of 60 students for the academic year 2016-17 was granted vide U.O. read as 3<sup>rd</sup> above.

3. The Director, Sahrdaya Institute of Management Studies, Kodakara, Thrissur has applied for Continuation of Provisional Affiliation to MBA programme for the academic year 2017-18, as per letter read as 4<sup>th</sup> above. An Inspection Commission was appointed for granting Continuation of Provisional Affiliation to MBA programme for the academic year 2017-18 vide U.O. read as 5<sup>th</sup> above.

4. The Inspection Commission after conducting inspection at the college recommended for Continuation of Provisional Affiliation to MBA programme at the college for the academic year 2017-18 and pointed out certain shortcomings in running the programme vide paper read as 6<sup>th</sup> above. Accordingly, vide paper 7<sup>th</sup> above the Principal has submitted satisfactory compliance report and the same has been accepted.

5. The College has remitted the required amount of Rs.1,20,000/- (Rupees One lakh twenty thousand only) as Administration fee & Affiliation fee and Rs. 5,000/- (Rupees Five Thousand only) as

inspection commission fee vide Chalan No.161641325 dated 07.12.2016 through SBT online payment.

6. As per paper read as 8<sup>th</sup> above, the College has submitted the AICTE Extension of Approval Order in respect of MBA programme in the college for the academic year 2017-18.

7. Sanction has, therefore, been accorded by the Hon'ble Vice Chancellor on 29.04.2017 for granting Continuation of Provisional Affiliation to MBA programme with an intake of 60 seats at Sahrdaya institute of Management Studies, Kallettumkara, Kodakara, Thrissur during the academic year 2017-18.

8. Affiliation granted is strictly provisional and only for the academic year 2017-18. The college has to apply for Continuation of Provisional Affiliation for the ensuing years by remitting the fee fixed by the University along with a copy of Extension of Approval from the apex body concerned.

9. The selection and admission shall be made only on the basis of the rules and regulations of the University and Government from time to time, failing which the affiliation granted will automatically be cancelled. The conduct of University Examinations of any sort including that of SDE Examinations is compulsory and binding on all Colleges affiliated to the University of Calicut.

10. The list of colleges which have renewed their provisional affiliation or applied for Continuation of provisional affiliation will be forwarded to the Office of the Controller of Examinations to see that examinations are not conducted in those colleges which have not applied for Continuation of Provisional Affiliation.

11. In the light of the directions of the Supreme Court of India WP(C) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent such instances, appropriate action including withdrawal of affiliation of the college will be initiated.
