## ORDER

Vide U.O. read as 1<sup>st</sup> above, Provisional Affiliation was granted to the new college viz. Sahrdaya Institute of Management Studies, Kallettumkara, Kodakara, Thrissur under Irinjalakuda Diocesan Educational Trust for conducting MBA programme with an intake of 60 seats during the academic year 2015-16.

- 2.As per the U.O. read as 2<sup>nd</sup> above, the MBA programme was suspended during the academic year 2015-16 with permission to restart the programme during the academic year 2016-17.
- 3.As per the U.O. read as 3<sup>rd</sup> above Continuation of Provisional Affiliation to MBA programme with an intake of 60 students at Sahrdaya Institute of Management Studies, Kallettumkara, Kodakara, Thrissur was granted for the academic year 2019-20.
- 4.The Director, Sahrdaya Institute of Management Studies, Kodakara, Thrissur has applied for Continuation of Provisional Affiliation to MBA programme in the college for the academic year 2020-
- 21, vide paper read as 4<sup>th</sup> above. An amount of Rs.1,32,300/-(Rupees One Lakh Thirty Two Thousand Three Hundred Only ) has been remitted towards Administration & Affiliation fee for MBA programme vide chalan No. 192278982 dated 29.12.19
- 5.The AICTE has extended its approval to the MBA programme for the academic year 2020-21 at Sahrdaya Institute of Management Studies, Kodakara, Thrissur vide paper read as 5<sup>th</sup> above.
- 6. The Principal has submitted necessary documents along with the application to the effect of having applied for renewal NOC from Government of Kerala.
- 7.Considering the above, sanction has been accorded by the Vice Chancellor for granting Continuation of Provisional Affiliation to MBA programme with an intake of 60 seats at Sahrdaya Institute of Management Studies, Kallettumkara, Kodakara, Thrissur for the academic year 2020-21 on conditional basis subject to the submission of renewal NOC from the Government of Kerala, for the academic year 2020-21.

- 8.Affiliation granted is strictly provisional and only for the academic year 2020-21 on conditional basis. The college has to apply for Continuation of Provisional Affiliation for the ensuing years by remitting the fee fixed by the University from time to time along the Approval order from the apex body concerned.
- 9. The selection and admission shall be made only on the basis of the rules and regulations of the University and Government from time to time, failing which the affiliation granted will automatically be cancelled. Admission to the next academic year shall be made only after obtaining prior permission from the university.
- 10. The list of colleges which have renewed their provisional affiliation will be forwarded to the Office of the Controller of Examinations to see that examinations are not conducted in the colleges without having valid affiliation order.
- 11. The conduct of University Examinations of any sort including that of SDE Examinations is compulsory and binding on all Colleges affiliated to the University of Calicut.
- 12.In the light of the directions of the Supreme Court of India WP(C) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent such instances, appropriate action including withdrawal of affiliation of the college will be initiated.
